



People's Resource Center Volunteer Agreement

Waiver and Release of Claims

I acknowledge and agree that I have decided to volunteer with People's Resource Center (PRC), that I will receive no compensation or other employment-related rights or benefits from PRC, that I am not an employee of PRC and that my volunteer services for PRC may be ended by me or PRC at any time and for any reason.

I acknowledge and understand that there are risks associated with volunteering with any organization, including PRC, that I may face including but not limited to personal injury to me or damage to or theft of my property. I further acknowledge and understand that these risks, including but not limited to the risk of bodily injury to me caused by lifting, a slip and fall, or harm that may be caused by others, cannot be completely controlled or prevented.

Accordingly, for good and valuable consideration, including but not limited to the privilege of volunteering with PRC, I hereby agree that I voluntarily assume any and all risks (both known and unknown) associated with my volunteer service for PRC, including but not limited to those risks described above. I further agree on my own behalf and on behalf of my representatives, assigns, and heirs to knowingly and voluntarily waive, discharge, release and further agree to not sue PRC (and its officers, directors, employees, agents, representatives, volunteers, and related parties) from and against any and all responsibility, liability, claims, demands, damages, costs, expenses (including attorneys' fees) or actions arising out of or relating in any way to my volunteer services with PRC, including, but not limited to, all actions based upon negligence and all claims for any personal or physical injury or damage to me or my property, whether occurring on PRC's premises or otherwise arising in connection with my volunteer services at PRC.

Confidentiality Agreement

As a volunteer of People's Resource Center (PRC), I agree that during the time that I am a volunteer with PRC and at all times thereafter I will keep confidential and will not directly or indirectly use or disclose any and all personal, privileged and/or confidential information regarding PRC that I obtain in the course of my involvement with PRC, including but not limited to information regarding clients' identity and personal information and PRC's organizational practices, projects, donors, potential donors, records, employees and volunteers.
